The correct product access configuration for Bob is Jira Administration with Product admin role and Jira Software with User role. This will allow Bob to update project schemes in Jira Software, as well as other project settings, without using a license. The Product admin role for Jira Administration grants access to the Jira Administration product, which is aseparate product from Jira Software that does not consume a license. The User role for Jira Software grants access to the Jira Software product, which does consume a license, but is necessary for Bob to view and edit project schemes12 References = Manage product access, Jira Administration overview

#### **QUESTION 3**

A group is deleted from your organization and then recreated with the same name.

When you delete a group from your organization, the group name and its members are removed from your organization\\'s directory. However, the group name and its members are not deleted from the products that the group had access to.

Therefore, if you recreate a group with the same name, the group will automatically regain access to the same products and inherit the same product roles and permissions that it had before deletion1. This means that the group membership

is automatically restored as a result of recreating the group with the same name.

The other options are not automatically restored as a result of recreating the group with the same name. Access to a User product role, access to a Product Admin role, global permissions, and access to shared filters are all productspecific

settings that depend on how the group is configured in each product. They are not affected by deleting or recreating the group from the organization\\'s directory1.
